## **5. Question Period**

### **5.1. Written Questions**

Ziegler - For the CRO/DRO: do you have any suggestions to improve the voter turn out for the AMA, in order to facilitate more questions, especially from people who are not direct friends of the candidates?

CRO – Online platforms, such as Facebook AMA, offer important avenues for voter engagement in modern democratic elections. The use of Facebook AMA in SAMU elections affords students the opportunity to interact with candidates, and get answers to questions about their election plans, in a setting that is moderated to ensure adherence to SAMU procedures and applicable University policies against harassment. Maximizing voter participation under this format is a challenge, and may require efforts on a couple of levels. Above all, as is typical with the ebbs and flows of politics, nothing is guaranteed in terms of increasing participation for the AMA forum. First, competitive races are crucial for generating enthusiasm, which means more students should be encouraged to put their names forward for SAMU elections. Second, SAMU should intensify its promotional efforts to get the word out about the Facebook AMA. Third, it is incumbent on all candidates to use their technological savviness and campaign resources to inform voters about this avenue for campaign engagement.

DRO – While I believe the voter engagement on the Facebook AMA was pretty high comparatively to previous forums for student engagement, I believe the best way to engage students to participate in any part of the election process is to have full races for all elected positions. This increases the engagement of the candidates, such as more classroom visits and face-to-face encounters in the hallway, which ultimately increases their outreach to the student body, allowing them to connect and provide information to potential voters. History has shown that when robust campaigning happens, students become more involved in the whole election process and are more likely to get out and vote.

Ziegler - For the President: Has the Leadership and Engagement Committee come up with any concrete ideas for engaging with Spring/Summer students?

Pres - No, we have not come up with concrete plans yet. We have been attempting to complete the items set out in the work plan. I have also been absent for a considerable amount for the month of March due to conferences, which unfortunately limits the available time for LEC meetings. There is now more flexibility for the committee and the new chair to consider other ideas.

Ziegler - For the President: what was the process employed to select Councilor Zielsdorf to sit on the Vice President University Relations Search Committee in your stead during the transition period?

Pres - There is no formal appointment process for being a part of search committees. Initially, the Executive decided it would be best for me to sit on the committee, as the position description of VP University Relations fit best within my portfolio. Unfortunately, the dates of the committee were set after the first meeting, and made it impossible for any outgoing or incoming EC member to sit on the committee. The meetings also extended much further into the summer period than I was first told. Last month as EC, we considered individuals who were likely to stay as councillors over the summer, continue as students into the Fall, and could handle the commitment if it extended further into the summer period. The first person I reached out to was Councilor Zielsdorf. She graciously accepted the opportunity. Had she not accepted, we would have likely asked another councillor.
